OUR USES AND DISCLOSURES

We may use and share your health information to:

Treat you

We may use your health information and share it with other professionals involved in your care.

Example: A case manager coordinating care with a primary care provider or specialist.

Run our organization

We use your information to manage our operations, improve services, and provide quality care.

Example: Reviewing client outcomes or training staff in best practices.

Bill for your services

We use your information to bill and collect payment from you directly.

Note: We do not accept insurance, and your information is not submitted to third-party payers unless required by law or you specifically authorize it.

Help with public health and safety issues

We may share information for the following reasons:

- Preventing disease
- Reporting adverse reactions to medications
- Reporting abuse, neglect, or domestic violence (when required)
- Preventing or reducing serious threats to health or safety

Comply with the law

We will share information if federal or state law requires it, such as for audits or law enforcement.

Work with medical examiners or funeral directors

We may share health information when someone passes away, if required by law.

Respond to lawsuits and legal actions

We may disclose information in response to a court order or subpoena.
